### Purpose of the Grant:

Promoting education has always been extremely important to the FOUNDATION . We believe that education is a key component to a healthy and vibrant community. For over 25 years, the FOUNDATION has been offering scholarships annually for post-secondary education. Since its creation, the scholarship committee has awarded over \$250,000 to High School seniors in Nampa and Melba.

In addition to the scholarships, the Nampa REALTORS® Foundation is offering a \$1,000 Grant in 2025.

The grant will provide supplemental funding for projects that cannot be solely funded by their District and other already available funds to teachers, staff and schools in the Nampa and Melba School District boundaries.

### Guidelines for requesting a grant from FOUNDATION:

- 1-Staff/teacher must be currently working at a school identified as recipient (Nampa or Melba school district, Nampa Christian)
- 2-Staff/Teacher must present the grant request in front of a committee if selected. (Virtual option is available).
- 3-Funds must be for the benefit of the school and/or its students and should be well researched for effect and expense.
- 4-All purchased items become the property of the school or school district.
- 5-Principal/Supervisor must sign the grant request form.
- 6- Teacher and supervisor agree the proceeds of the grant will be used for the project and not for other purposes
- 7- Award recipient may be required to present the project to the FOUNDATION Scholarship Committee during a membership event. Date to be determined. PowerPoint and video arrangements can be made.
- 8- Amount of funds awarded per grant application is at the sole discretion Committee and approved by the Nampa REALTORS® Foundation Board of Directors
